## Pilot Flying J Giveaway Official Rules

# Valid December 1, 2025 – December 7, 2025 NO PURCHASE NECESSARY TO PLAY OR WIN

### **HOW IT WORKS:**

On any given date that Pilot Travel Centers LLC ("Sponsor") announces via Facebook that the Sponsor is giving away a number of specific prizes (each a "Giveaway"), these terms and conditions will apply.
